SECTION 4: First aid measures
4.1. Description of first aid measures
General information

First aider: Pay attention to self-protection! Remove affected person from the danger area and lay down. Remove casualty to fresh air and keep warm and at rest. Causes severe skin burns and eye damage. Ingestion causes burns of the upper digestive and Respiratory tract. After swallowing copper sulphate, gastrointestinal complaints such as metallic taste, nausea, vomiting, burning or pain behind the breastbone occur quickly. Depending on the concentration of liquid preparations, but especially if crystals are swallowed, deep burns are to be expected. In severe cases, bloody diarrhoea and circulatory collapse as well as disintegration of red blood cells (haemolysis), jaundice (icterus), liver and kidney damage are possible. 8.2. Exposure controls
