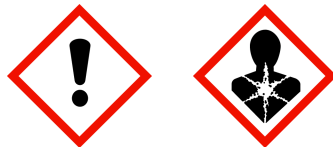

SECTION 4: First aid measures

4.1. Description of first aid measures

General information

First aider: Pay attention to self-protection! In case of accident or unwellness, seek medical advice immediately (show directions for use or safety data sheet if possible).

Remove contaminated, saturated clothing immediately. Remove affected person from the danger area and lay down. Remove person to fresh air and keep comfortable for breathing.

After inhalation

After ingestion

If accidentally swallowed rinse the mouth with plenty of water (only if the person is conscious) and obtain immediate medical attention. Observe risk of aspiration if vomiting occurs. Let water be drunken in little sips (dilution effect). Medical treatment necessary.
